ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be:

Professional Teen Network, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Said Corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Specifically, Professional Teen Network, Inc. will:

1. Provide educational and cultural enrichment activities and events to enlighten/enhance the awareness of teenagers/youth/young adults between the ages of 13-21. This will be done to encourage them to further their educational enrichment.
2. Incorporate FCAT Math Tutoring, Academic trips to colleges and universities, educational trips in and out of state, focus groups, health awareness fairs, self-esteem workshops, mentoring groups, parenting skills workshops, employability skills seminars, teen and youth summits, and college fairs.
3. Upon the dissolution of Professional Teen Network, Inc. , assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for public purpose.

Notwithstanding any other provision of these Articles, Professional Teen Network, Inc. will not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The business of Professional Teen Network, Inc. shall be managed by the Board of Directors. This corporation shall have three directors initially. The number of Directors may be increased from time to time by the bylaws, but shall never be less than two. The Board of Directors shall be elected and hold office in accordance with the bylaws.

The business and affairs of the corporation shall be managed by the Board of Directors, in addition to any powers conferred herein or in the By-Laws, the Board of Directors may, subject to any express limitation contained in these Articles of Incorporation or in the By-laws, exercise the full extent of powers conferred by the laws of the State of Florida upon corporations or directors thereof and the enumeration and definition of particular powers herein or in the By-Laws shall in no way be; deemed to restrict or otherwise limit those lawfully conferred powers. In furtherance and without limitation of the foregoing, the Board of Directors shall have the power to make, alter, amend or repeal from time to time the By-Laws of the corporation.

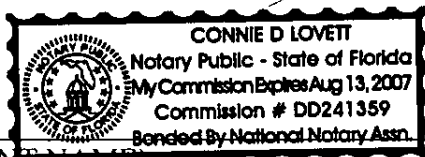
