ARTICLE I NAME

The name of the corporation shall be:

The purpose for which the corporation is organized is:

The manner of admission to membership in said Corporation shall be by letter of dismission from other churches of like faith and order and by satisfactory statement of former membership in a Church of Christ and profession of faith as hereinbefore provided, upon a favorable majority vote of the membership of said corporation present at any meeting of said church hereinafter admitted to such membership shall constitute the membership of this corporation.

ARTICLE IV MANNER OF ELECTION
