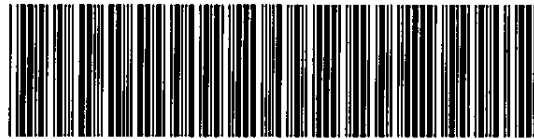

## ARTICLES OF INCORPORATION

OF

### OAK TREE BAPTIST CHURCH, INC.

The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida Not for Profit Corporation Act, by and under the provisions of the Statutes of the State of Florida, hereby adopts the following Articles of Incorporation.

#### ARTICLE I - NAME

The name of the corporation shall be OAK TREE BAPTIST CHURCH, INC.

#### ARTICLE II - OFFICE

The principal office of this corporation shall be situated at 1745 STATE ROAD 100, MELROSE, FLORIDA 32666 and said corporation shall have the rights and privileges of business in such states of the United States and foreign countries whenever the Board of Directors may from time to time order and establish.

#### ARTICLE III - REGISTERED AGENT

The street address of this corporation's initial registered office will be 1745 STATE ROAD 100, MELROSE, FLORIDA 32666 and the name of its initial registered agent will be REV. SAM ATKINSON at such address

#### ARTICLE IV - NATURE OF BUSINESS

The purposes and powers of this corporation are to engage in and have unlimited power to do any and all lawful purposes, by all lawful powers, of the laws of the State of Florida. However, in the event of dissolution, remaining assets of the corporation shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or shall be distributed to the Federal government, or to a state or local government, for public purpose.

## ARTICLE VI - POSITIONS

The business of this corporation shall be conducted by a Board of Directors consisting of one or more persons.

The officers of this corporation shall be a President, a Vice-President, a Secretary, a Treasurer, and such other officers as shall be appointed in accordance with the by-laws of this corporation

## ARTICLE VII - DIRECTORS

Directors. The manner in which directors are elected is as follows: An organizational meeting is held in which the original incorporators elect a chairman and the board of directors all in accordance with the by-laws of the corporation.

## ARTICLE XI - ORGANIZATION ACTIVITIES



Notwithstanding any other provision of these articles, the corporation/organization shall not carry on any other activities nor permitted to be carried on (a) by corporation/organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code ( or corresponding section of any future Federal tax code) or (b) by a corporation/organization, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

## ARTICLE XII - DISSOLUTION

Upon the dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.
