FOR

## Article One

**The name for the corporation is. Full of Faith Ministry Gods Hands and Eyes are upon you. The blood of Jesus INC.**

## ARTICLE TWO

**The principal place of business and the mailing address of this corporation shall be

## ARTICLE THREE

**The general purpose for which this corporation is formed are to interpret and expound the Holy Bible: to maintain it as the foundation of all spiritual truth: to establish a church: to ordain ministers of the Gospel, authorized by it to teach and minister unto its members, perform marriages, administer Sacraments and burial of the dead, and to Exercise such authority over its membership through suitable regulations and bylaws as may be appropriate for the establishment and maintenance of a sect of the Christian Faith and for such religious purposes as will qualify it as an exempt organization under Section 501 ©(3) of the Internal Revenue Code of 1985, as amended, or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code, as may be amended from time to time.**
