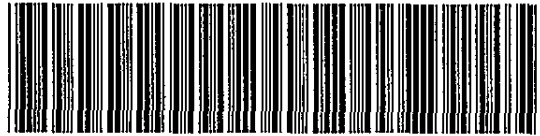

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be the Lake Concert Band, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: The purpose of the Lake Concert Band, Inc. is to provide an outlet for its members to pursue their musical aptitudes and provide various music styles to the public for their enjoyment and relaxation through concerts performed throughout the Central Florida Area.
