ARTICLES OF INCORPORATION OF

CHILDREN OF ROYALTY TRANSPORTATION SERVICES. INC.

We, the undersigned with other persons being desirous of forming a corporation under the provision of Chapter 617.0501 or 607.0501, of the Florida Statutes do agree to the following:

ARTICLE I

The name of this Corporation is: CHILDREN OF ROYALTY TRANSPORTATION SERVICES, INC. AND ITS PRINCIPAL OFFICE IS LOCATED AT 1233 NW 27TH AVENUE, POMPANO BEACH, FL 33069.

ARTICLE II

This corporation shal have the rights to promote spiritual and intellectual welfare of the people of the State of Florida; the buying, selling, conveying, accepting and being invested with all manner of estate, real, personal and mixed. To operate a day care, to provide transportation for after school care, provide tutoring for youth and children.
