## ARTICLES OF INCORPORATION In Compliance with Chapter 617, F.S., (Not for Profit)

#### Article I - Name:

The name of this organization shall be "THE APPLEBOTTOM RYDERS MOTORCYCLE CLUB, INC.

#### **Article II – Principle Place of Business:**

The principal office of the Corporation is to be located in Florida, the City of Daytona Beach, in Volusia County. The mailing address for this business is 223 S. Martin Luther King Blvd, Daytona Beach, Florida 32114.

#### Article III - Purpose, Goals and Objectives:

**PURPOSE:** To establish an organization with a social and civic aspect, designed to create a spirit of camaraderie that will enhance the prestige and motorcycle riding experience of all members, encourage on-going rider education and skills development, increase public awareness and reduce motorcycle mishaps. #### **Article X - Event of Dissolution:**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. AppleBottom Ryders Motorcycle Club, Inc. shall distribute any remaining assets to similar non-profit organizations to assist them in meeting similar goals. And/Or, any remaining assets will be donated to other charitable organizations benefiting children, homeless or the disabled.
