### ARTICLES OF INCORPORATION

We, the undersigned, each with the capacity to contract, hereby execute and acknowledge these Articles of Incorporation for the purpose of forming a corporation not for profit under and by virtue of the laws of the state of Florida. The undersigned hereby adopts the following Articles of Incorporation.

#### **ARTICLE 1:NAME**

The name of the corporation shall be: JacQue Strappy Ministries, Incorporated

The Principle place of business of the corporation shall be: 3141 SE 20<sup>th</sup> Avenue Gainesville, FL 32641

Mailing address of the corporation shall be: 3141 SE 20<sup>th</sup> Avenue Gainesville, FL 32641

#### **ARTICLE 2: PURPOSE**

As a Christian Community Empowerment and Mentorship Ministry, the specific and primary purpose for which this corporation is initially organized is to establish, oversee and provide venues for the development of Christian ethics, moral stamina, personal and family empowerment through workshops, support groups and mentoring programs. Provide places and means for outreach missionary activities, worship, religious training and evangelism provided by ordained and licensed ministers of the Gospel. To secure and operate places and or means for, mentoring, support groups, and community outreach missions and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with section 501(c)(3) of the Internal Revenue Code. This corporation is organized and operated to operate exclusively for religious, charitable and educational purposes as will qualify it as an exempt organization under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any subsequent federal tax code.

Not withstanding any other provisions of theses articles, this corporation will not carry on any other activities not permitted to be carried on by(i) a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, or (ii) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Internal Revenue law. The purposes for which this corporation is organized are exclusively charitable, literary and educational within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law.

#### ARTICLE 6. INITIAL REGISTERED OFFICE AND AGENT

The name of the initial Registered Agent of the corporation is Minister Jacquelin P. Strappy and the street address of the initial registered agent of this corporation is 3141 SE 20<sup>th</sup> Avenue Gainesville, FL 32641.

#### **ARTICLE 7. INCORPORATOR**

#### ARTICLE 8. DIRECTORS

The board of directors of the corporation shall consist of no less than (3) directors as determined by the bylaws. The directors named in these articles shall serve as directors for the ensuing year, or until the first annual meeting of the corporation, and any vacancies before then shall be filled in the manner set forth in the bylaws. The board of directors shall have the authority to make provision for reasonable compensation to its members for their services as directors and to fix the basis and conditions upon which the compensation shall be paid. Any director may also serve the corporation in any other capacity and receive compensation there from in any form.
