# ARTICLES OF INCORPORATION

## GILBERT ATHLETIC ASSOCIATION, INC.

A Florida not for Profit Corporation

In compliance with the laws of the state of Florida, the undersigned do hereby voluntarily associate for the purpose of forming a corporation Not-For-Profit for the propose and with powers set forth herein.

#### <u>ARTICLE I – NAME</u>

The name of the corporation is GILBERT ATHLETIC ASSOCIATION, INC.

#### <u>ARTICLE II – PRINCIPAL OFF</u>ICE

The principal office of the corporation shall be located at 1379 Florida Avenue Jacksonville, Florida 32206, but the Corporation may maintain offices and transact business in such places, within or without the state of Florida, as may from time to time be designated by the Board of Directors. The principal office shall also be the matting and registered office address.

#### **ARTICLE III – PURPOSE**

The purposes of this corporation shall be exclusively charitable and educational and undertake the following activities:

- To plan and implement projects that will benefit the community as a whole by A. providing a wide rage of social, recreational, educational, vocational and cultural services to citizens of all ages.
- B. To establish programs and to work with others organizations and agencies for the betterment of the youth, adult and senior citizens in the community.

- D. To build and keep a stronger community by utilizing the GAAI.
- E. To undertake any other projects or lawful activities consistent with Section 501 © (3) of the Internal Revenue Code which may me necessary, useful, desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly and either alone or in conjunction or cooperation with others, whether such other be persons or organizations of any kind or nature, such as corporations, firms, associations, trusts, institutions, foundations, governmental bureaus, departments or agencies.

- F. Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by a organization exempt from Federal and State Income Tax under section 501 © (3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue law. No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation. The corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office.
- G. For such purpose, the Corporation shall have and exercise the following authority and powers.
  - 1. To have and to exercise any and all powers, right and privilege which a corporation organized under the law of the State of Florida may now or hereafter have.
  - 2. To do all things necessary or desirable to accomplish the purposes of the Corporation as the Directors of the Corporation may from time to time deem appropriate which are consistent with powers conferred upon a not-for-profit corporation under the laws of the state of Florida and the Internal Revenue Code.
  - 3. To purchase, take, receive, lease, take by gift, devise or bequest, or otherwise acquire, own, hold, improve, use or otherwise deal in and with real or personal property or any interest therein, wherever situated.
