THE UNDERSIGNED Subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a not for profit corporation under the laws of the State of Florida; and further agree to the following conditions of said Corporation.

ARTICLE I: NAME

The name of the Corporation is: NEW JERUSALEM COMMUNITY CHURCH, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation in the State of Florida shall be: 914 Church Avenue, Panama City, Florida 32401.

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is to conduct the Christian ministry of the New Jerusalem Community Church and to do all things which natural persons and lawful entities might or could lawfully do in the premises and to transact any lawful business for which corporations may be incorporated under the laws of Florida.

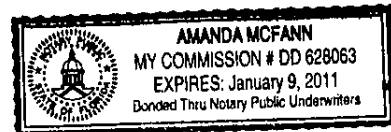
