

**PLAN OF DISTRIBUTION OF ASSETS  
JIM EVANS ONE UMPIRE AT A TIME FOUNDATION, INC.**

Jim Evans One Umpire at a Time Foundation, Inc. (the "Corporation"), in connection with the Corporation's dissolution, shall distribute its assets in accordance with the following:

- (a) All liabilities and obligations of the Corporation shall be paid and discharged, or adequate provisions be made therefor;
- (b) Assets held by the Corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirements;
- (c) Assets received and held by the Corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution, shall be transferred or conveyed to one or more domestic or foreign corporations, trusts, societies, or organizations engaged in activities substantially similar to those of the dissolving Corporation, as provided in this Plan of Distribution of Assets;
- (d) Other assets, if any, shall be distributed in accordance with the provisions of the Corporation's Articles of Incorporation or the Bylaws to the extent that the Articles of Incorporation or the Bylaws determine the distributive rights of members, or any class or classes of members, or provide for distribution to others; and
- (e) Any remaining assets shall be distributed to such persons, trusts, societies, organizations, or domestic or foreign corporations, whether for profit or not for profit, as specified in this Plan of Distribution of Assets.

A copy of this Plan of Distribution of Assets, authenticated by an officer of the Corporation and containing the officer's certificate of compliance with the requirements of subsection (1) or subsection (2) of Section 617.1406 of the Florida Not For Profit Corporation Act shall be filed with the Florida Department of State.
