2. The dissolution of the corporation was authorized on June 10, 2009 with an effective date of June 10, 2009, ~~and a filing date of June 16, 2009.~~

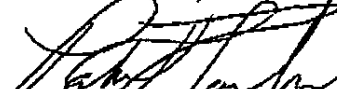
3. The dissolution of the corporation was authorized by the unanimous vote of the directors.

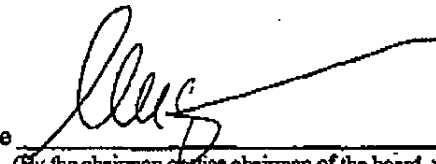
