CONSTITUTION

PASSED BY DEERIELD

Article I. - NAME

THE NAME OF THE ORGANIZATION SHALL BE WHEELS OF MAN M.C. OF LEVY COUNTY INC.

Article II - DEFINITION

ORGANIZATION SHALL BE AN INDEPENDENT NOT FOR PROFIT MEMBERSHIP SOCIETY. GOVERND BY THE NATIONAL CHAPTER, WHEELS OF MAN M.C. INC., OF DEERFIELD BEACH, FL.

Article III - PURPOSES, POLICIES AND OBJECTIVES

THE PURPOSES, POLICIES AND OBJECTIVES OF THIS ORGANIZATION ARE:

A. TO PROVIDE A FACILITY FOR PROMOTING FELLOWSHIP AND THE INTERCHANGE OF EXPERIENCE AND INFORMATION AMONG OWNERS, RIDERS AND OTHERS INTERESTED IN ALL MOTORCYCLES AND TO ENCOURAGE SAFE AND SPORTSMAN-LIKE CONDUCT ON THE PUBLIC HIGHWAYS.

B. TO PROVIDE ACTIVITIES PERTAINING TO MOTORCYCLES.

Article IV - OPERATIONS AND CONDUCT

ITS CERTIFICATES OF INCORPORATION, ITS CONSTITUTION AND ITS BY-LAWS SHALL GOVERN THIS ORGANIZATION.

Article V - MEMBERSHIP

A. ELIGIBILITY- ANY PERSON OVER 21 YEARS OF AGE OWNING A MOTORCYCLE OF 650 CC OR OVER SHALL BE ELIGIBLE FOR MEMBERSHIP.

B. ASSOCIATE MEMBERSHIP MAY BE CONFERRED BY THE BOARD OF DIRECTORS OF THIS ORGANIZATION ONLY ON PERSONS WHO MAKE OUTSTANDING CONTRIBUTIONS TO THE WHEELS OF MAN M. C., INC.

Article VI - OFFICERS

THIS ORGANIZATION SHALL HAVE A PRESIDENT, VICE PRESIDENT, TREASURER, SERGEANT- AT-ARMS, ROAD CAPTAIN, SECRETARY AND CHAPLAIN, WHO SHALL COMPRISE THE BOARD OF DIRECTORS. THE FOREGOING OFFICERS SHALL BE ELECTED BY THE MEMBERSHIP AND SHALL HOLD OFFICE FOR ONE YEAR OR UNTIL THEIR SUCCESSORS SHALL QUALIFY. NO INDIVIDUAL MAY HOLD MORE THAN ONE OFFICE.

Article VII - MEETINGS

BUSINESS MEETINGS SHALL BE HELD AT LEAST ONCE EACH WEEK UNLESS THE BOARD OF DIRECTORS SHALL RULE OTHERWISE DUE TO AN ACTIVITY BEING SUPPORTED BY THE MEMBERSHIP. MEETINGS OF THE BOARD OF DIRECTORS SHALL BE HELD AS OFTEN AS IS DEEMED NECESSARY BY SAID BOARD FOR THE GOOD AND WELFARE OF THE ORGANIZATION.

Article VIII - AMENDMENTS

IN ORDER TO AMEND THIS CONSTITUTION, THERE SHALL BE AT LEAST SEVENTY FIVE PERCENT (75%) OF THE TOTAL VOTING MEMBERSHIP PRESENT. A SEVENTY-FIVE PERCENT (75%) AFFIRMATIVE VOTE OF THOSE AFOREMENTIONED IS NECESSARY TO PASS THE AMENDMENT. THE TOTAL MEMBERSHIP OF THE ORGANIZATION SHALL BE NOTIFIED BY MAIL OF ANY PROPOSED AMENDMENT TO THIS CONSTITUTION AT LEAST 10 DAYS IN ADVANCE OF THE MEETING AT, WHICH THE PROPOSED AMENDMENT IS TO BE ACTED UPON.
