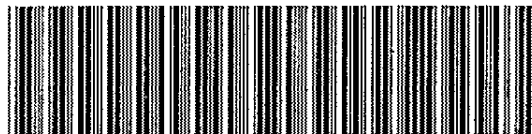

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. With the specific purpose of bringing theater to the North River area of Manatee County Florida and the residence of the North River area into the Theater within the aforementioned setting. Also including all items listed within the proper attached charter Article VIII, and proper attached declaration of trust article IX.
