ARTICLES OF INCORPORATION

FOR

ARTICLE I.

The name of this corporation shall be Holla Back Foundation, Inc.

This nonprofit organization for the general purpose, pursuant to the Florida Corporation Not For Profit Laws as set forth in Chapter 617, Florida Statues, and shall have perpetual existence. The Foundation shall commence existence on the date these Articles are filed with the Secretary of State.

ARTICLE II.

The location of the principal office of the corporation shall be; 806 Golden Street Tallahassee, Florida 32304

ARTICLE III.

The purposes for which this corporation is organized are:

- (a) To operate in any manner supportative of religious, charitable and educational efforts consistent with the criteria to qualify as an exempt organization under Section 501 (c) 3 of the Internal Revenue laws, including laws for private Foundations;
- (b) To develop, maintain, provide, and participate in educational programs for the general public, for church and religious organizations, and private groups;
- (c) To provide assistance to troubled teens;
- (d) To provide support and assistance for community development and economic development, and
- (e) To receive, invest, and disburse funds and to hold property for the purpose of the corporation.

ARTICLE IV.

The number of Directors of the corporation shall not be more than (7) seven nor less than (5) five. The manner in which Directors are elected or appointed shall be set forth in the By-Laws of the Foundation which are to be adopted at the initial meeting of the Foundation

The co shall be expressly prohibited from conducting or carrying on propaganda or otherwise attempting to influence the Legislature, or intervening in any political campaign on behalf of any candidate for public office, or any other activity not permitted to be carried on by a Foundation exempt from income tax under Section 501 (c) 3 of the Internal Revenue Code of 1986, or any other corresponding provisions of any future Internal Revenue Laws.

ARTICLE V.

In the event of the disposition of any surplus or abandoned property of the Foundation, or upon dissolution, voluntarily or otherwise, the assets of the Foundation shall not inure to the benefit of any member or individual, but shall be transferred to one or more other exempt Foundation as described in Section 501(c)3 or 170(c)2 of the Internal Revenue Code of 1986. Which shall have as its primary purpose those same responsibilities as specified in Article III hereof are as may be performed by the Directors of this Foundation in furtherance of such responsibilities.
