# ARTICLES OF INCORPORATION

(A Corporation Not For Profit)

The undersigned being desirous of forming a corporation not for profit under the provisions of 720 and 617 of the Florida Statutes, and in accordance with all pertinent laws of the State of Florida, do hereby subscribe and adopt the following Articles of Incorporation for such corporation:

#### **ARTICLE I**

#### Name

The name of this corporation is: Northbrook of Nassau Homeowners Association, Inc. The initial principal address of the corporation is 86002 Christian Way, Yulee, Florida 32097.

#### ARTICLE II

#### Purpose

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to operate a homeowners association which will manage the common areas of Northbrook Subdivision and will, in addition to its other duties, operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water
