

AMENDMENT TO ARTICLES OF INCORPORATION OF INTERNATIONAL AQUATIC FOUNDATION, INC.

WHEREAS, the Articles of Incorporation of International Aquatic Foundation, Inc., dated February 27, 2007, and filed on March 8, 2007, with the Secretary of State of Florida ("Articles");

NOW, THEREFORE, pursuant to Chapter 617 of the Florida Statutes, the Corporation hereby amends the Articles as follows:

I. ARTICLE I is hereby amended to read as follows:

ARTICLE I

The name of the Corporation shall be INTERNATIONAL AQUATIC & SPORTS FOUNDATION, INC. The principal place of business of this corporation shall be 4726 Bay Point Road, Unit 41414000 Marriott Drive, Suite 3503, Panama City Beach, Florida 32408.

II. ARTICLE IV is hereby amended to read as follows:

ARTICLE IV

The number constituting the <u>initial</u>-Board of Directors of the Corporation <u>isshall</u> currently be <u>ninefifteen</u> (915). The number of directors may be either increased or diminished from time to time in accordance with the Bylaws, and shall always be an odd number of between three (3) and <u>thirteenseventeen</u> (1317).
