The name of this corporation is Nord Ouest Environmental, Inc..

The term for which this corporation shall exist shall be perpetual.

111.

The general nature of the business or businesses to be transacted by said corporation shall be as follows:

To protect the environment with a focus on South Florida, the Caribbean and West Indian countries; to educate the public and governmental officials in Florida, Haiti, Caribbean nations and other places about the environmental impact of their actions, decisions and policies; to supply and address the charitable need of children and families that are negatively impacted by environmental deficiencies; to raise and collect funds and supplies to meet the need of children and families that are negatively impacted by environmental policies and actions and circumstances, to address environmental issues and related matters including housing, employment, social services, education, and training.

That of engaging in any activity permitted under the laws of the United States of America, its territories, districts, and possessions, and any activity permitted under the laws of the State of Florida, and to have, exercise, and enjoy the powers and privileges granted to corporations not for profit by Chapter 617, Florida Statutes.


