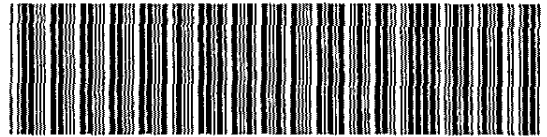

In Compliance with Chapter 617, F.S., (**Not for Profit**)
