A FLORIDA NOT FOR PROFTIT CORPORATION

The undersigned, for the purpose of forming a not for profit corporation, in compliance with Chapter 617, Florida Statutes, hereby state:

ARTICLE I - NAME

The name of the corporation is: Florida: On Your Side, Inc.

ARTICLE II - PRINCIPAL OFFICE

The initial street address of the principal office of the corporation is: 14480 62[™] Street North, Clearwater, FL 33760. The corporation may from time to time move its principal office to another location. The mailing address of the corporation shall be: Post Office Box 6025, Clearwater, FL 33758.

ARTICLE III - PURPOSE

The purpose of the corporation is to:

- A. Facilitate the discussion of public policy issues of importance to the residual Pinellas County County, Florida, as well as the State of Florida;
