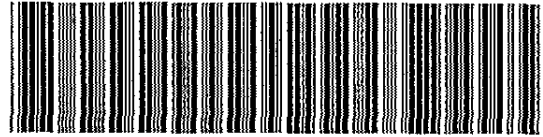



The undersigned subscriber to these Articles of Incorporation hereby forms a Not For Profit Corporation under the laws of the State of Florida.

**ARTICLE I**

The name of this Corporation is The Apostle Henry Ross Sr. Family Life Center, Inc.

**ARTICLE II**

The initial principal address of the corporation shall be 1302 Martin Luther King Jr. Boulevard, Lakeland, Florida, 33805.

**ARTICLE III**

The corporation is organized for the purpose of promoting religious, scholastic, educational, and athletic endeavor in compliance with Section 501(c)(3) of the Internal Revenue Code of 1986.

**ARTICLE IV**

The directors of the corporation are to be elected at the annual meeting of membership or as otherwise provided in the By-Laws.

**ARTICLE V**

Under no circumstances shall any of the net earnings or assets of the corporation inure to the benefit of any member, director, or officer of this corporation, except that the corporation is empowered to make payments and distributions to carry out the purpose of the corporation. The corporation shall not, in any manner, participate in any political campaign on behalf of any candidate for public office. The corporation shall not carry on any activity not permitted to be engaged in by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, as amended, or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, as amended.

**ARTICLE VI**

The street address of the initial registered office of this corporation is 1302 Martin Luther King Jr. Boulevard, Lakeland, Florida, 33805, and the name of the initial registered agent of this corporation is Rufus E. Slater.

The incorporator is Rufus E. Slater, 1302 Martin Luther King Jr. Boulevard, Lakeland, Florida, 33805.


### ARTICLE VIII

This corporation shall have one (1) Director initially. The number of Directors may be increased or decreased from time to time by the By-Laws, but shall never be less than one. The name and address of the initial Director of this Corporation is Rufus E. Slater, 1302 Martin Luther King Jr. Boulevard, Lakeland, Florida, 33805.

### ARTICLE IX

Upon dissolution, the Board of Directors, after payment of the liabilities of the corporation, shall dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such a manner, or to such organizations under Section 501(c)(3) of the Internal Revenue Code, as amended, as determined by the Board of Directors.



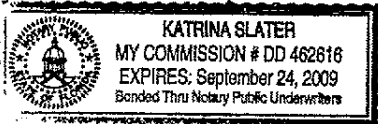
