ARTICLES OF INCORPORATION

OF

PARK PLACE INDUSTRIAL CENTER ASSOCIATION, INC.

The undersigned incorporator (the "incorporator"), hereby subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation not-for-profit in accordance with the Laws of the State of Florida,

ARTICLE I NAME AND ADDRESS

The name of this corporation shall be: Park Place Industrial Center Association, Inc. Its address shall be: 34851 Highway 54, Suite 101, Zephyrhills, Florida 33541, or such other address as it may hereafter select.

ARTICLE II DEFINITION OF TERMS

2.01 "Articles of Incorporation" shall mean the Articles of Incorporation of the "Association" (as hereinafter defined), together with all modifications and amendments thereto.

2.02 "Association" shall mean the Park Place Industrial Center Association, Inc., a not for profit corporation organized under the laws of the State of Florida,

2.03 "Board" shall mean the duly elected or appointed board of directors of the Association,

2.04 "By-Laws" shall mean the duly adopted By-Laws of the Association, together with all modifications and amendments thereto.

2.05 "Park Place Industrial Center" or the "Property" shall mean all or any portion of the Exhibit "A" Property which is subdivided pursuant to the plat approved by Pasco County, Florida, unless prior to any such approval, Declarant has recorded an instrument in the public records of Pasco County, Florida, excluding such portion of the Exhibit "A" Property from the
