ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CRYSTAL PRESERVE HOMEOWNERS ASSOCIATION, INC.

Pursuant to Florida Statutes, section 617.1006, the Articles of Incorporation of the above named corporation are hereby amended to add the following provisions:

ARTICLE XVII SURFACE WATER MANAGEMENT

The Association has the power to operate and maintain the surface water management system facilities, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, ponds, lakes, floodplain compensation areas, wetlands and any associated buffer areas, and wetland mitigation areas.

If the Association is dissolved, the control or right of access to the property containing the surface water management system facilities shall be conveyed or dedicated to an appropriate governmental unit or public unit and that if not accepted, then the surface water management system facilities shall be conveyed to a non-profit corporation similar to the Association.
