**PLAN OF DISTRIBUTION**  
*of*  
**NEVIASER CHARITABLE FOUNDATION, INC.**

This Plan of Distribution (this "**Plan**"), dated as of September 12, 2018 (the "**Plan Date**"), is intended to liquidate the assets of Neviaser Charitable Foundation, Inc., a Florida not-for-profit corporation (the "**Corporation**") in accordance with the Chapter 617, Florida Statutes.

1. **APPROVAL OF THE PLAN.** This Plan shall become effective upon the approval and adoption thereof by the affirmative vote of a majority of the members of the Board of Directors (the "**Directors**") as evidenced by the officer's certificate of compliance, attached hereto as **EXHIBIT A**.

2. **PAYMENT OF LIABILITIES AND OBLIGATIONS.** Upon the approval and adoption of the Plan by the Board of Directors of the Corporation, the Corporation shall pay or make provision for the payment of, all obligations of, all liabilities of, and claims against the Corporation.

3. **INDEMNIFICATION.** The Corporation shall continue to indemnify its officers, Directors, and employees in accordance with the Florida statutes, the Corporation's Articles of Incorporation, Bylaws, any contractual arrangements, and its existing directors' and officers' liability insurance policy (as applicable), for acts and omissions in connection with the implementation of this Plan.

4. **TRANSFER OF ASSETS.** All assets held by the Corporation upon condition requiring return, transfer, or conveyance by reason of liquidation shall be returned, transferred, or conveyed in accordance with the requirements set forth in the Articles of Incorporation or the Bylaws, in the manner specified on **EXHIBIT B-4**.

5. **CHARITABLE ASSETS.** All assets received and held by the Corporation for charitable purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution, shall be transferred or conveyed to one or more domestic or foreign or corporations, trusts, societies, or organizations for further charitable purposes, pursuant to the Articles of Incorporation and Bylaws, in the manner specified on **EXHIBIT B-5**.

6. **OTHER ASSETS.** All other assets, if any, shall be distributed in accordance with the provisions of the Articles of Incorporation or the Bylaws to the extent that the Articles of Incorporation or the Bylaws determine the distributive rights of members, or any class or classes of members, or provide for distributions to others, in the manner specified on **EXHIBIT B-6**.

7. **REMAINING ASSETS.** Any remaining assets shall be distributed in the manner specified on **EXHIBIT B-7**.

8. **MISCELLANEOUS.** Subject to the foregoing, the Corporation, by and through the Directors, has discretion in determining the manner and timing in which the distributions are to be completed.
