A FLORIDA NOT FOR PROFIT CORPORATION

The undersigned, for the purpose of forming a not for profit corporation, in compliance with Chapter 617, Florida Statutes, hereby state:

ARTICLE I - NAME

The name of the corporation is: Keep Martin County Green PAC, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

The purpose of the corporation is to:

- A. Advocate, as a matter of public policy, issues that preserve the environmentand natural resources of Martin County, Florida, and to oppose issues that encourage development of Martin County, Florida;
- B. Inform residents of Martin County, Florida, through the production of advertisements or direct mailings, regarding issues that preserve the environment and natural resources of Martin County, Florida, and to oppose issues that encourage development of Martin County, Florida;
- C. Implement such programs to make the public aware of issues that preserve the environment and natural resources of Martin County, Florida, and to oppose issues that encourage development of Martin County, Florida;
- D. Do other acts necessary and appropriate, including accepting contributions and making expenditures, to accomplish these purposes.

ARTICLE IV - ELECTION OF DIRECTORS

ARTICLE X - DISTRIBUTION OF ASSETS

In the event of the dissolution or final liquidation of the corporation, all of the remaining assets and property of the corporation shall, after paying or making provision for the payment of all the liabilities and obligations of the corporation and for necessary expenses thereof, be distributed to such entities as determined by the directors for the purposes set forth in Article III hereof. In no event shall any of such assets or property be distributed to any officer or director of the corporation or to any private individual.
