**ARTICLES OF INCORPORATION
KEEP MARTIN COUNTY GREEN, INC.**

A FLORIDA NOT FOR PROFIT CORPORATION

The undersigned, for the purpose of forming a not for profit corporation, in compliance with Chapter 617, Florida Statutes, hereby state:

ARTICLE I - NAME

The name of the corporation is: Keep Martin County Green, Inc.

ARTICLE II - PRINCIPAL OFFICE

The initial street address of the principal office of the corporation is: 11450 SE Dixie Highway, Suite 202, Hobe Sound, FL 33455. The corporation may from time to time move its principal office to another location.

ARTICLE III - PURPOSE

The purpose of the corporation is to:

- A. Advocate, as a matter of public policy, environmental preservation and conservation of the natural resources of Martin County, Florida;
- B. Inform residents of Martin County, Florida, through the production of advertisements or direct mailings, of such environmental conservation issues of importance to the natural resources of Martin County, Florida, and of the views of public officials and others participating in public affairs on those issues;
- C. Implement such programs to make the public aware of such environmental conservation issues of importance to the natural resources of Martin County, Florida, and of the views of public officials and others participating in public affairs on those issues;
- D. Do other acts necessary and appropriate, including accepting contributions and making expenditures, to accomplish these purposes.

ARTICLE IV - ELECTION OF DIRECTORS

The directors of the corporation shall be elected as provided in the bylaws of the corporation.


ARTICLE IX - CONFLICT OF INTERESTS

In no way directly or indirectly, incidentally or otherwise, shall any part of the earnings of the corporation inure to the benefit of, or be distributed to any director or officer of the corporation, or any other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation and to make payment for actual expenditures incurred or services rendered to or for the benefit of the corporation and to make payments and distributions for the purposes set forth in Article III hereof.

ARTICLE X - DISTRIBUTION OF ASSETS

In the event of the dissolution or final liquidation of the corporation, all of the remaining assets and property of the corporation shall, after paying or making provision for the payment of all the liabilities and obligations of the corporation and for necessary expenses thereof, be distributed to such entities as determined by the directors for the purposes set forth in Article III hereof. In no event shall any of such assets or property be distributed to any officer or director of the corporation or to any private individual.


