Peace Place

Mission Statement:

Peace Place is a non profit organization which will assist women who are in recovery from alcohol and substance abuse. Peace Place will provide these women with an opportunity to live in an environment that cultivates confidence, and empowers them to believe in their own potential through educational and vocational training. The goal of the program is to help female alcoholic and drug addicts gain the tools that they need to live sober, productive lives. Peace Place will provide them with a safe nurturing home environment to live in while they develop a healthy and self sustaining way of life.

Targeted Audience & Program Requirements:

The organization will house women who are being released from jails, treatment centers, and or institutions, in which progress is being supervised by the court system. Admission to the program will be on a volunteer/ referral basis only. Potential residents will have been stabilized (clean and sober) for a minimum of sixty days. Admission to Peace Place is dependent upon an essay and entrance interview depicting their willingness to achieve long term sobriety and goals.

Residence:

The facility is a multi unit apartment complex consisting of an administration office, computer room, classroom, and a common area for meetings. Each bedroom will be occupied by two to four residents depending on room size. Residents will be directly responsible for keeping their immediate area clean and in sanitary conditions. Furthermore, residents will be required to share responsibilities of the maintenance for the apartments and the property in general, including all common areas.

Program Overview:

Clients accepted into the program will be required to commit to a 4 to 12 month stay. Random drug testing provided by the courts, and full participation in all program activities are required to maintain residence. The organization will serve as a follow up facility to hospitalization, incarceration and or drug treatment programs helping to insure the success of women who are on the path to changing their lives. Peace Place will not accept women with a history of violence and or severe mental or physical disabilities. Following the application process areas to be evaluated include: the clients level of willingness, background education level, and her goals. Upon acceptance a specific plan of action will be tailored to the clients' special needs with a timetable for achievement. This plan of action will be the basis for a contract with Peace Place. Peace Place has sovereign authority in the decisions concerning acceptance, rejection, and or expulsion of unruly residents, thus being returned to the courts.
