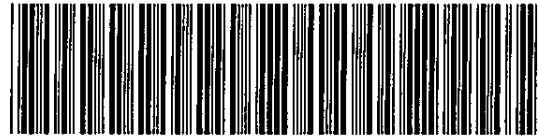

**ARTICLES OF INCORPORATION:
TOGETHER WE CAN ACHIEVE INC.**

ARTICLE I

Name/Registered Office

The name of this corporation shall be: Together We Can Achieve Inc.
The corporation's registered office is located at:
235 30th Street, West Palm Beach Florida 33407.
The mailing address: 235 30th Street West Palm Beach Florida 33407.

ARTICLE II

Purpose

This corporation is organized exclusively for educational purposes within the meaning of Section 501(c) 3 of the Internal Revenue Code of 1986 as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c) (3) exempt organizations. To this end, the corporation Together We Can Achieve Inc. will be the catalyst for change in the community of Lake Park by empowering families and individuals to improve their quality of life. This change will occur through educational outreach provided by TWCA. Adult literacy will be the hallmark of TWCA programming. The community that TWCA will serve has a large Haitian population who are recent immigrants to south Florida. Providing recent immigrants with the life skills instruction necessary to assimilate successfully into daily life in South Florida will be the focal point of TWCA activities. These life skills will be centered on financial management, job skills improvement, healthcare acquisition, and parental interaction priorities for successful child education.

ARTICLE III

Limitations

1. No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501 (c) (3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor at any Director or officer of the corporation, nor to any other private persons, excepting solely such reasonable

compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;

2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including on behalf of, or in opposition to), any candidate for public office; and
3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.
4. The corporation shall not lend any of its assets to any officer or director of this corporation, or guarantee to any person the payment of a loan by an officer or director of this corporation.

ARTICLE IV

Directors/Members

Together We Can Achieve Inc. shall have non-voting members. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. No Director shall have any right, title or interest in or to any property of the corporation. The Board of Directors of Together We Can Achieve will be comprised of the following natural persons:

ARTICLE V

Debt Obligations and Personal Liability

No member, officer, or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor

shall any of the property of the members, officers, or Directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VI Dissolution

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
