## ARTICLES OF INCORPORATION OF VICTORIA ARBOR HOMEOWNERS'

ICLES OF INCORPORATION OF VICTORIA ARBOR HOMEOWINE.

ASSOCIATION, INC.

The undersigned, by these Articles, hereby associate for the purpose of forming a rion not for profit pursuant to Chapter 617 of the laws of the State of Florida and rios of Incorporation: corporation not for profit pursuant to Chapter 617 of the laws of the State of Florida, and adopts the following Articles of Incorporation:

The name of corporation shall be VICTORIA ARBOR HOMEOWNERS' ASSOCIATION, INC. For convenience, the corporation may be referred to in this instrument as the "Association". these Articles of Incorporation as the "Articles" and the By Laws of the Association as the "By Laws." The principal place of business and mailing address of the Association shall be 2901 W. Busch Blvd, Suite 901, Tampa, Florida 33618 or such other place as may be subsequently designated by the Board of Directors.

#### **ARTICLE 2**

#### **PURPOSE**

The purpose for which the Association is organized is to provide an entity pursuant to the Chapter 720 of Florida Statutes ("Act") to operate a homeowner's association located in Pasco County, Florida ("Association") to be known as VICTORIA ARBOR HOMEOWNERS' ASSOCIATION. The purposes also include:

- 2.1 To provide for the maintenance, preservation and architectural control of Lots and Common areas (including Surface Water Management System) and to promote the health, safety and welfare of the Residents within the Development.
- 2.2 To accept and hold fee simple title to the common area an to accept and hold the rights, titles and interest of the Association as Grantee to any Easement that is appurtenant to the common area or to which the Association is a benefited party.
- 2.3 To operate and maintain the Surface Water Management System in accordance with the terms and conditions of the Environmental Resource Permit as issued by the Southwest Florida Water Management District.

The Association is not organized for profit and no part of the net earnings, if any, shall inure to the benefit of any Member or other Person.

#### ARTICLE 3

#### **DEFINITIONS**

The capitalized terms used in these Articles shall have the same definitions and meanings as those set forth in the Declaration of Covenants, Conditions and Restrictions of the Homeowners' Association ("Declaration") to be recorded in the Public Records of Pasco County, Florida, unless provided to the contrary in these Articles, or unless the

context otherwise requires. The term "Person" shall include individuals, corporations, partnerships, trusts, limited liability companies and other legal entities.

#### **ARTICLE 4**

#### **POWERS**

The powers of the Association shall include and be governed by the following:

- 4.1 General. The Association shall have all of the common-law and statutory powers of a corporation not for profit under the Laws of Florida that are not in conflict with the provisions of these Articles, the Declaration, the By-Laws or the Act.
- 4.2 Enumeration. In addition to, and not in limitation of, the powers described in Paragraph 4.1, the Association shall have all of the powers and duties set forth in the Act except as limited by these Articles, the By-Laws and the Declaration, and all of the powers and duties reasonably necessary to operate the Homeowners' Association and to exercise such powers, duties and obligations described in the Declaration, as it may be amended from time to time, including, but not limited to, the following:
- (a) To make, collect and enforcement of payment of Assessments and other charges against Owners, and to use the proceeds in the exercise of its powers and duties. Consent of two-thirds (2/3) of each Class of Membership is required for any mortgage, pledge, or hypothecation of any real or personal property as security for money borrowed or debts incurred.
- (b) To acquire, buy, own, operate, lease, sell, trade and mortgage both real and personal property as may be necessary or convenient in the administration of the Association and to make contracts and perform acts necessary for carrying on the Association. This specifically includes the right to enter into contracts for the operation and management of the Surface Water Management System.
- (c) To maintain, repairs replace, reconstruct, add to and operate the Association Property, and other property acquired or leased by the Association for use by Owners.
- (d) To purchase insurance upon the Association Property and insurance for the protection of the Association, its officers, directors and Members as Owners.
- (e) To make and amend reasonable rules and regulations for the maintenance, conservation and use of the Association Property and Common Area and for the health, comfort, safety and welfare of the Owners.
  - (f) To sue and be sued.
- (g) To enforce by legal means the provisions of the Act, the Declaration, these Articles, the By-Laws, and the rules and regulations for the use of the Association's Property.
- (h) To contract for the management of the Association and any facilities used by the Owners to assist the Association in carrying out the powers and duties of the Association contained in these Articles or in the Declaration. In exercising this power, the Association may contract with affiliates of itself and/or Developer.

- (i) To employ personnel to perform the services required for the proper operation of the Association.
- (j) To execute all documents or consents, on behalf of the owners (and their mortgagees), required by all governmental and/or quasi-governmental agencies in connection with land use and development matters (including, without limitation, plats, waivers of plat, unities of title, covenants in lieu thereof), and in that regard, each owner, by acceptance of the deed to such owner's Lot, appoints and designates the Board of Directors as such owner's agent and attorney-in-fact to execute, any and all such documents or consents.
- (k) To dedicate, sell or transfer all or any part of the Common Area to any public agency, authority or utility for such purposes and subject to such conditions as may be agreed to by the Members. No such dedication, sale or transfer shall be effective unless an instrument agreeing to such dedications, sale or transfer has been signed by any Members entitled to each not less than two-thirds (2/3) of the votes of each Class of Members of the Association.
- 4.3 <u>Property.</u> All funds and the titles of all properties acquired by the Association and their proceeds shall be held for the benefit and use of the Members in accordance with the provisions of the Declaration, these Articles and the By-Laws.
- 4.4 <u>Distribution of Income</u>. The Association shall make no distribution of income to its members, directors or officers and upon dissolution all assets of the Association shall be transferred only to another not for profit corporation or public agency.
- 4.5 <u>Limitation</u>. The powers of the Association shall be subject to and shall be exercised in accordance with the provisions of these Articles, the Declaration, the By-Laws and the Act provided that in the event of any conflict, the provisions of the Act shall control over the Declaration, these Articles and the By-Laws.

#### **ARTICLE 5**

#### **MEMBERS**

- 5.1 Membership. Every person or entity who is a record owner, from time to time, of a Lot subject by covenants of record to assessment by the Association shall be a member of the Association. Classes of membership may be established pursuant to the Declaration of Covenants, Conditions and Restrictions recorded for the Land. Any owner of more that one Lot shall be entitled to one (1) membership for each Lot owned by him. Membership shall be appurtenant to and may not be separated from ownership of any Lot which is subject to assessment by the Association. Change of membership in the Association for an Owner shall be established by recording in the Public Records of Pasco County, Florida, a deed or other instrument establishing record title to a Lot in the Development and by delivery of a recorded copy of the same to the Association. The Owner designated by such deed becomes a member of the Association and the membership of the prior Owner is terminated.
  - 5.2 Voting. The Association shall have two (2) classes of members:
- a. <u>Class A.</u> Class A members shall be all Owners, except the Developer, of Lots and shall be entitled to one (1) vote for each such Lot so owned.

- b. <u>Class B.</u> The Class B member shall be the Developer. The Developer shall be entitled to 9 votes for each Lot owned. The Class B membership shall cease and be converted to Class A membership when the total votes outstanding in Class A membership equals or exceeds the total votes outstanding in the Class B membership, or December 31, 2010, whichever first occurs.
- 5.3 <u>Meetings of Members</u>. The By-Laws shall provide for an annual meeting of Members, make provision for regular and special meetings of Members other than the annual meeting and set the quorum requirements for meetings of the Members.
- 5.4 No Transfer or Hypothecation. No Owner may assign, hypothecate or transfer in any manner membership in the Association or the funds and assets of the Association except as an appurtenance to such Owner's Lot.
- 5.5 <u>Loss of Membership</u>. Any Member who conveys or loses title to the Member's Lot by sale, gift, judicial decree or otherwise shall, immediately upon such conveyance or loss of title, no longer be a Member with respect to such Lot and shall lose all rights and privileges of a Member resulting from ownership of such Lot,

#### **ARTICLE 6**

### **TERM OF EXISTENCE**

The Association shall have perpetual existence.

#### **ARTICLE 7**

#### INCORPORATOR

#### **ARTICLE 8**

### **DIRECTORS**

- 8.1 <u>Number and Qualification</u>. The property, business and affairs of the Association shall be managed by a Board consisting of the number of Directors determined in the manner provided by the By-Laws, but which shall consist of not less than three Directors. Initially the number of Directors shall be three. The Directors, other than those designated by Developer, shall be Members of the Association and Owners or their spouses.
- 8.2 <u>Duties and Powers</u>. All of the duties and powers of the Association existing under the Act, the Declaration, these Articles and the By-Laws shall be exercised exclusively by the Board of Directors, its agents, contractors or employees, subject only to approval by Owners when such approval is specifically required.
- 8.3 Election and Removal. Directors of the Association shall be elected at the annual meeting of the Members in the manner determined by and subject to the

qualifications set forth in the By-Laws. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided by the By-Laws.

- 8.4 <u>Term of Developer's Directors.</u> During the period Developer is entitled to elect one or more Directors, Developer shall appoint the Directors and their replacements who shall hold office for the periods described in the By-Laws. Any Director appointed by Developer may be removed by Developer at any time without cause and Developer may designate a replacement Director. Any Director designated by Developer cannot be removed by Owners except pursuant to the Act.
- 8.5 <u>First Directors</u>. The names and addresses of the members of the first Board of Directors who shall hold office until their successors are elected and have qualified, as provided in the By-Laws, are as follows:

8.6 Standards of Conduct. A Director shall discharge his or her duties as a Director, including any duties as a member of a Committee: in good faith; with the care an ordinary prudent person in a like position would exercise under similar circumstances; and in a manner reasonably believed to be in the best interests of the Association. Unless a Director has knowledge concerning a matter in question that makes reliance unwarranted, a Director, in discharging his or her duties, may rely on information, opinions, reports or statements, including financial statements and other data, if prepared or presented by: one or more officers or employees of the Association whom the director reasonably believes to be reasonable and competent in the manners presented; legal counsel, public accountants or other persons as to matters the Director reasonably believes are within such person's professional or expert competence; or a Committee of which the Director is not a member if the Director reasonably believes the Committee merits confidence. A Director is not liable for any action taken as a director, or any failure to take action, if he or she performed the duties of his office in compliance with the foregoing standards.

#### ARTICLE 9

#### **OFFICERS**

The affairs of the Association shall be administered by the officers holding the offices designated in the By-Laws. The officers shall be elected by the Board of Directors of the Association and shall serve at the pleasure of the Board of Directors. The By-Laws may provide for the removal from office of officers, for filling vacancies and for the duties of the officers. The names and addresses of the officers who shall serve until their successors are designated by the Board of Directors are as follows:

President: Vincent Bekiempis

Vice President and Assistant: Vincent Bekiempis

Secretary and Treasurer: Vincent Bekiempis

#### **ARTICLE 10**

#### **INDEMNIFICATION**

- 10.1 Indemnity. The Association shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or contemplated action, suit or proceeding, whether civil, criminal, administrative or investigative (collectively "Action"), by reason of the fact that he or she is or was a director, employee, officer or agent of the Association (collectively "Association Person"), against expenses (including attorneys' fees and appellate attorneys' fees), judgments, fines and amounts paid in settlement actually and reasonably incurred by the Association Person in connection with such Action, if the Association Person acted in good faith and in a manner the Association Person reasonably believed to be in, or not opposed to, the best interests of the Association and with respect to any criminal action or proceeding, had no reason to believe the Association Person's conduct was unlawful. The Association shall not, however, indemnify any Association Person as to matters to which the Association Person shall be finally adjudged in any such Action to be liable for gross negligence or gross misconduct in the performance of the Association Person's duty. The termination of any Action by judgment, order, settlement, conviction or upon a plea of nolo contendere or its equivalent shall not, of itself, create a presumption of gross negligence or gross misconduct. The foregoing right of indemnification shall be in addition to any other rights to which an Association Person may be entitled as a matter of law or otherwise.
- 10.2 Expenses. To the extent that an Association Person has been successful on the merits or otherwise in defense of any Action, or in defense of any claim, issue or matter regarding such Action, the Association Person shall be indemnified against expenses (including attorneys' fees and appellate attorneys' fees) actually and reasonably incurred in such Action.
- 10.3 Approval. Any indemnification under Paragraph 10.1 (unless ordered by a court) shall be made by the Association only as authorized in the specific case upon a determination that indemnification of the Association Person is proper under the circumstances because the Association Person has met the applicable standard of conduct set forth in Paragraph 10.1. Such determination shall be made (a) by the Board of Directors by a majority vote of a quorum consisting of Directors who were not parties to such Action, or (b) if such quorum is not obtainable, or, even if obtainable, if a quorum of disinterested Directors so directs, by independent legal counsel in a written opinion, or by a majority of the Members.
- 10.4 Advances. Expenses incurred in defending an Action may be paid by the Association in advance of the final disposition of such Action, as authorized by the Board of Directors in any specific case upon receipt of an undertaking by or on behalf of the Association Person to repay such amount unless it shall ultimately be determined that the Association Person is entitled to be indemnified by the Association as authorized in this Article 10.
- 10.5 <u>Miscellaneous</u>. The indemnification provided by this Article shall not be deemed exclusive of any other rights to which those seeking indemnification may be entitled under any by-law, agreement, vote of Members or otherwise, and shall continue

as to a person who has ceased to be an Association Person and shall inure to the benefit of the heirs and personal representatives of such person.

- 10.6 <u>Insurance</u>. The Association shall have the power to purchase and maintain insurance on behalf of any person who is or was an Association Person or is or was serving, at the request of the Association, as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise, against any liability asserted against him or her and incurred by him or her in any such capacity, or arising out of his or her status as such, whether or not the Association would have the power to indemnify him or her against such liability under the provisions of this Article.
- 10.7 <u>Directors Appointed by Developer</u>. Any Director appointed by Developer shall not be entitled to indemnification under this Article 10 if same would violate then applicable law.

#### ARTICLE 11

#### **BY-LAWS**

The first By-Laws of the Association shall be adopted by the Board of Directors and may be altered, amended or rescinded by the Directors, Members and Developer in the manner provided in the By-Laws and the Declaration.

#### **ARTICLE 12**

#### **AMENDMENTS**

Amendments to these Articles shall be proposed and adopted in the following manner:

- 12.1 Notice. Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which the proposed amendment is to be considered.
- 12.2 <u>Adoption</u>. A resolution for the adoption of a proposed amendment may be proposed either by a majority of the Board of Directors or by not less than one-third of the votes of Members of the Association. Directors and Members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing the approval is delivered to the Secretary at or prior to the meeting.

#### The approvals must be:

- (a) by not less than a majority of the votes of all of the Members represented at a meeting at which a quorum has been attained and by not less than 66-2/3% of the Board of Directors; or
- (b) by not less than 80% of the votes of all of the Members represented at a meeting at which a quorum has been attained; or
  - (c) by not less than 100% of the Board of Directors.
- 12.3 <u>Limitation</u>. No amendment shall make any changes in: the qualifications of membership; the voting rights or property rights of Members; Paragraphs 4.3, 4.4 or 4.5 of Article 4, entitled 'Powers' or this Paragraph 12.3, without, in each case, the approval in writing of all Members and the joinder of all record owners of mortgages upon Lots.

No amendment shall be made that is in conflict with the Act, the Declaration or the By-Laws, nor shall any amendment make any changes which would in any way affect any of the rights, privileges, powers or options provided in favor of or reserved to Developer (or any affiliate), unless Developer shall join in execution of the amendment. No amendment to these Articles shall be made which adversely affects the rights of Institutional Mortgagees without the prior written consent of a majority of holders of mortgages on the Lots held by Institutional Mortgagees.

- 12.4 <u>Developer</u>. Developer may amend these Articles consistent with the provisions of the Declaration allowing certain amendments to be effected solely by Developer.
- 12.5 <u>Recording.</u> A copy of each amendment shall be filed with the Secretary of State pursuant to the provisions of applicable Florida law, and a copy certified by the Secretary of State shall be recorded in the public records of Hillsborough County, Florida.

#### **ARTICLE 13**

## **OFFICE; REGISTERED AGENT**

The initial registered office of the Association shall Nancy G. Farage, Esquire, Nancy G. Farage, P.A., 707 N. Franklin Street, Tampa, Florida 33602 or P.O. Box 173027, Tampa, Florida 33672, with the privilege of having its office and branch offices at other places within or without the State of Florida. The initial registered agent at that address shall be Nancy G. Farage.

#### **ARTICLE 14**

#### DISSOLUTION

The Association may be dissolved with the consent given in writing and signed by not less than two-thirds of each Class of members of the Association. Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which the Association was created. In the event that dedication is refused acceptances, such assets shall be granted, conveyed, and assigned to any nonprofit corporation, association, trust or other organization to be devoted to such similar purposes.

Upon dissolution of the Association, all Members (Lot owners) shall be jointly and severally responsible for operation and management of the Surface Water Management System according to the requirements of the Environmental Resource Permit issued by the Southwest Florida Water Management District until an alternate entity assumes responsibility for same.

These Articles of Incorporation have been duly approved by the undersigned as and constituting all of the initial subscribers and directors of said corporation.
