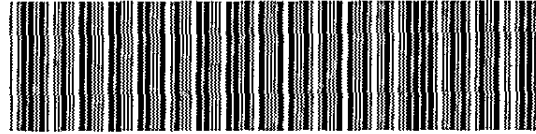

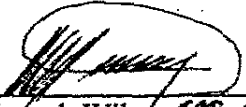

ARTICLES OF INCORPORATION  
OF  
**World League of Evangelism and Bible Teachers, Inc.**  
I

The name of this corporation is **World League of Evangelism and Bible Teachers, Inc.**  
NONPROFIT CORPORATION.

II

The term for which this corporation shall exist shall be perpetual.

III

The general nature of the business or businesses to be transacted by said corporation shall be as follows:

To foster, support, and engage in activities relative to religious concepts, goals, and ideals, including any and all activities are lawful and appropriate in accordance with the tenets of Christianity and the laws of the State of Florida. **World League of Evangelism and Bible Teachers, Inc.** shall engage in activities and programs that serve its congregation and the community at large, and which serve to promote religion, human development, mutual understanding, and public service.

That of engaging in any activity permitted under the laws of the United States of America, its territories, districts, and possessions, and any activity permitted under the law of the State of Florida, and to have, exercise, and enjoy the powers and privileges granted to corporations not for profit by Chapter 617, Florida Statutes.

To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes, of the attainment of any of the objects, or for the furtherance of the powers herein set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid business of powers, or our part thereof, provided, that the name be not inconsistent with the laws under which this corporation is organized.

The purposes for which the **World League of Evangelism and Bible Teachers, Inc.** is organized are exclusively religious, charitable, scientific, literary and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations within the meaning of section 501 C (3) of the Internal Revenue Code of 1986 or the corresponding section of any future tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make

payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501-C (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170-C (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501-C (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170-C (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### IV

Newly created directorships or vacancies in the Board of Directors may be filled by a vote of majority of the Board of directors. A director elected to fill a vacancy caused by resignation or death, or removal shall be elected to hold office. Member shall be qualified for admission, and shall be admitted as members, in accordance with the by-laws of this

Corporation, a two-thirds vote of the membership shall be required for the election of new directors or for the removal of current directors.

#### V

The street address of the initial registered office of this corporation is: 13381 Memorial Hwy Apt 5 Miami, Florida 33161, and the initial registered agent at that address is: Rev. J. Wilson Marcelin

#### VI

This corporation shall have as directors initially those persons designated in this Article below. The number of directors may be either increased or decreased from time to time by the By-Laws, but shall never be less than three (3) nor more than fifteen (15). 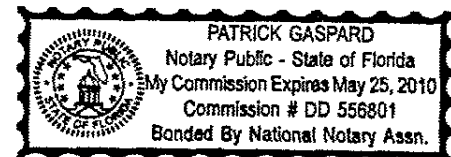
