ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I
NAME

The name of this corporation shall be: Autism Scholarship Foundation, Inc.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
3727 A Anuhea Street, Honolulu, Hawaii, 96816

ARTICLE III
PURPOSE

This corporation is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the corporation shall pursue the charitable goals of (i) fundraising for the purpose of providing quality education and treatment to children with autism, (ii) promoting awareness of Autism Spectrum Disorder, and (iii) engaging in any other related lawful activity in the furtherance of items (i) through (ii). All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE IV
MANNER OF ELECTION

The officers of the corporation shall be elected annually by a majority vote of the Board of Directors. If the election of officers shall not be held at such meeting, such election shall be held as soon thereafter as convenient. New offices may be created and filled at any meeting of the Board of Directors by majority vote. Each officer elected herein shall hold office until a successor shall have been duly elected, subject to early termination by removal or resignation.
