ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S.
Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned nonprofit corporation adopts the following articles of amendments to its Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: The Good Shepard of North East Florida Incorporated

ARTICLES II: PRINCIPLE OFFICE

The principle office of the non-profit agency will be located in the City of Lake City, Florida, in the County of Columbia. The Corporation will provide services to Suwannee, Hamilton, Madison, Columbia, Jefferson, and Taylor counties. The Corporation shall designate a registered office in accordance with the State of Florida Law and shall maintain it continuously.

ARTICLES III: PURPOSE

The purpose for which the corporation was organized is:

1. This corporation is a charitable non-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person.
2. To exercise all rights and powers conferred by the laws of the State of Florida upon a non-profit corporation.

Provided, that the corporation shall not engage in any activity which is not permitted to by charitable non-profit corporations under the Internal Revenue Code and no part of the net earning of the corporation shall be Insure to benefit it's board members; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions to these people in furtherance of it stated purpose. This corporation is organized exclusively for one (1) or more purposes specified in Section 501(c) 3 of the Internal Revenue Code, including for such purposes, the

making of distributions to organizations that qualify as exempt organization under Section 501 (c) 3 Internal Revenue Code; or corresponding section of any future federal tax code.

3. The length of time for the agency shall be as long as it takes to meet the planned programs.
4. The agency wants the rural communities in North Florida to be able to assist the families with long term affordable housing and feeding the hungry in the areas where it is necessary

ARTICLE IV: MANNER OF ELECTIONS

1. The Corporation has initially excepted people from within the community that has the same plans in mind for assisting those that have no other way out of the poverty location that they currently find themselves living in.
2. This current Board of Directions will serve at least (1) one year, after which they will be elected.
3. The other rights and privileges of the manner of election will be put in the by-laws.
