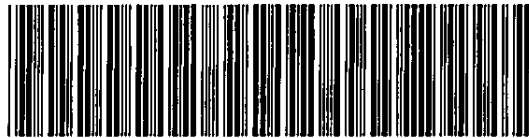

# ARTICLES OF INCORPORATION

FOR

**MARIAN'S GIFT, INC.**

In compliance with the provisions of Chapter 617, Florida Statutes, the undersigned, for the purpose of forming a Not for Profit Corporation, does hereby make, subscribe, acknowledge and file in the office of the Secretary of State of the State of Florida, as the Articles of Incorporation of **Marian's Gift, Inc.**, a Florida corporation, the following, to wit:

## Article I - Corporate Name

The name of the corporation is as follows:

**MARIAN'S GIFT, INC.**

## Article II - Principal Office

The principal place of business for which the corporation is organized is:

168 Mills Road  
DeLand, Volusia County, Florida 32724

## Article III - Purpose

The corporation is organized for the purpose of engaging in the charitable business of providing assistance to senior citizens in home repair as permitted under the laws of the State of Florida, the United States, the Internal Revenue Code, or the corresponding section of any future federal tax code.

## Article IV - Duration

This corporation shall exist perpetually unless dissolved in accordance with its Bylaws or pursuant to Florida law.

## Article V - Manner of Election

This corporation shall have three (3) directors initially. The number of directors may be either increased or diminished from time to time by the Bylaws, but shall never be less than three (3).

## Article VI - Initial Directors AND/OR Officers

### **Article VII - Earnings/Contributions**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three (3) hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

### **Article VIII - Dissolution**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
