Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation:

Article III of the Articles of Incorporation shall be deleted in its entirety and shall be replaced with the following:

Article III

The Corporation is organized exclusively for educational purposes as provided in Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The specific purposes for which this Corporation is organized are to educate and inform the public concerning issues relating to identity theft through the use of lectures, seminars and/or the dissemination of materials and other information.

The Articles of Incorporation shall be amended by adding the following Article:

Article IX

Upon dissolution of the Corporation, the assets of the Corporation shall be distributed to ANIMATED DRIVERS ED., INC., a Florida Not-For-Profit Corporation. Provided, however, that the assets of the Corporation shall not be distributed to ANIMATED DRIVERS ED., INC. unless, at the time of the dissolution of the Corporation, said recipient of the assets shall be exempt under Section 501(c)(3) of the Internal Revenue Code. If, at the time of the dissolution of the Corporation, ANIMATED DRIVERS ED., INC. is not exempt under Section 501(c)(3) of the Internal Revenue Code, the assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of, shall be disposed of by a Court of Competent Jurisdiction in Palm Beach County, Florida, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
