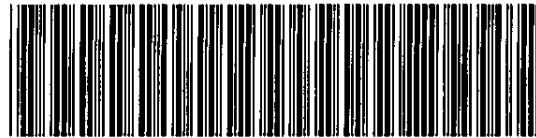

ARTICLES OF INCORPORATION  
OF  
MUSTARD SEED COMMUNITIES, INC.  
(A Corporation Not For Profit)

The undersigned hereby submit the following Articles of Incorporation for the formation of a corporation not-for-profit in accordance with the laws of the State of Florida.

I  
NAME

The name of the corporation shall be MUSTARD SEED COMMUNITIES, INC. (the "Corporation").

II  
PURPOSES

MUSTARD SEED COMMUNITIES, INC. is a nonprofit corporation organized for the following general purposes: to establish and operate a fund, from which to purchase goods and services for the poor, the collection of food, clothing, furniture and equipment, medication and other necessities and the distribution of same to the poor, both within and outside the United States of America, and the receiving, acquiring and holding or distributing of gifts, donations, devises and bequests. The goods acquired shall be used solely for the education, feeding, medical service and the provision of other services required to improve the lives of the poor which the corporation shall serve.

This Corporation is organized and shall be operated exclusively for charitable purposes, including for such purposes the making of distributions to qualified organization. An organization is a "qualified organization" for purposes of these Articles only if it is described in Section 501(c)(3) and Sections 509 (a)(2) of the Internal Revenue Code of 1986, or corresponding sections of any future federal tax code. If a qualified organization ceases to be a qualified organization, this Corporation shall not make any further distributions to such organization.

III  
MEMBERSHIP REQUIREMENTS

1. Active members of the Corporation shall be limited to such persons who, in the sole judgment of the Directors, are sincerely interested in philanthropic causes, generally, and in the purposes of the Corporation, specifically. The Board may from time to time establish more rigorous criteria for the qualifications and obligations of members but until such time membership shall be limited to no more than 10 persons.

2. Each active member shall be entitled to one vote in the affairs of the Corporation. Proxy voting is permitted.

3. Any member ceasing to have the necessary qualifications as set forth in the Bylaws shall be expelled from the membership, as may be provided in the Bylaws.

#### IV DURATION

The Corporation shall have perpetual existence.

#### V PRINCIPAL OFFICE

The principal office of the Corporation shall be located at 6401 Lyons Road, Coconut Creek, Florida 33073, but the Corporation may maintain offices and transact business in other places within or without the State of Florida as may from time to time be designated by the Board; furthermore, the Board may from time to time relocate the principal office of the Corporation.

#### VI REGISTERED AGENT

The registered office of MUSTARD SEED COMMUNITIES, INC. shall be located at 6401 Lyons Road, Coconut Creek, Florida 33073. The name and address of the initial registered agent of MUSTARD SEED COMMUNITIES, INC. is David T. Price, Esq., 6401 Lyons Road, Coconut Creek, Florida 33073.

#### VII DIRECTORS

1. The Board of Directors shall consist of a number of directors determined in accordance with the Bylaws, but not less than three directors.

2. The directors of the Corporation shall be elected at the annual meeting of the Members of the Corporation in the manner determined by the Bylaws. Directors may be removed and vacancies on the Board shall be filled by the Members in the manner provided in the Bylaws.

## VIII OFFICERS

The affairs of the Corporation shall be managed by the directors and the officers in accordance with the Bylaws. The officers shall be appointed from time to time by the Board. Officers shall serve at the pleasure of the Board.

## IX BYLAWS

The first Bylaws shall be adopted by the directors and may be altered, amended or rescinded by the directors in the manner provided by the Bylaws.

## X AMENDMENT

These Articles may be amended or repealed, in whole or in part, in accordance with the provisions set forth in Florida Statute 617.1002 (2).

## XI DISSOLUTION

Upon dissolution of this Corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any further Federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.

XII  
RESIDENT AGENT FOR SERVICE OF PROCESS

In pursuance of Chapter 48.091, Florida Statutes, the following is submitted in compliance with said Act.

That MUSTARD SEED COMUNITIES, INC. desiring to organize under the laws of the State of Florida with its principal office, as indicated in the Articles of Incorporation at the City of Coconut Creek, County of Broward, State of Florida, has named David T. Price located at 6401 Lyons Road, Coconut Creek, County of Broward, State of Florida, as its Agent to accept services of process within this State.


