

FIRST ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE

Pursuant to the provisions of Section 617.1002, Florida Statutes, this Florida not for profit corporation adopts the following amendment to its Articles of Incorporation.

AMENDMENTS ADOPTED

ARTICLE VI

Article VI is amended to read as follows:

BOARD OF DIRECTORS, MANAGEMENT AND MEMBERSHIP

Section 1: The affairs of the Corporation shall be managed by a Board of Directors who may receive compensation and reimbursement for expenses. The Board of Directors shall consist of not less than three (3) and no more than twenty-one (21) Directors. Directors shall be appointed and removed in accordance with the procedure provided for in the Corporation Bylaws.

Section 2: No change.

Section 3: The Corporation shall have a single Member and the Member shall be AIDS Healthcare Foundation, located at 6255 West Sunset Boulevard, 21st Floor, Los Angeles, California 90028.

The effective date of the adoption of this amendment was October 1, 2007. The amendment was adopted by the Board of Directors of AIDS Healthcare Foundation Disease Management of Florida, Inc., and there were no members entitled to vote on said amendment.
