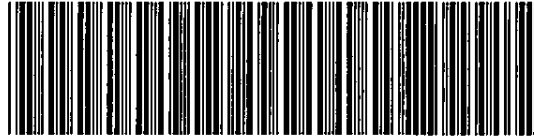

ARTICLE I
NAME

The name of this corporation is CENTRAL AREA NEIGHBORHOOD ASSOCIATION OF WILTON MANORS, INC.

ARTICLE II
DURATION

This corporation shall have a perpetual existence.

ARTICLE III
PURPOSE

This homeowners association is organized for the purpose of providing a forum for the residents of the defined area to meet, discuss and solve issues that impact the well being of the neighborhood. These issues include, but are not limited to, zoning, city ordinances, crime, traffic patterns, beautification, special events and health and welfare of the neighborhood residents. This association will seek to generate an active membership that will identify and solve problems of the neighborhood. This group will operate as a non-profit association with allegiance only to the membership.

ARTICLE IV
QUALIFICATIONS OF MEMBERS AND THE MANNER OF THEIR ADMISSION

Membership in this association is open to any person at least 18 years of age who is a resident or property owner within the following geographical limits:

The area to be included in this association shall be bounded on the South by the south fork of the Middle River, on the East by North Dixie Highway, on the West by North Andrews Avenue, and on the North by the North by Oakland Park Boulevard, excluding any area outside the boundary of the City of Wilton Manors, Florida.

ARTICLE V

ARTICLE VI
OFFICERS AND THE AFFAIRS OF THE CORPORATION

There will be an initial four (4) officers who are Naomi Parker (P), Constance Ruppender (VP), Marcel Martin (S) and Jack Moore (T). The officers of the association shall consist of a president (P), a vice-president (VP), a secretary (S) and a treasurer (T).

Nominations for association officers shall be made by a nominating committee appointed by the President or other association officer conducting the January meeting. This committee shall consist of three members in good standing, including the immediate past president, if possible. This committee shall present its report and recommendations at the February meeting of the members in good standing who have consented to serve if elected. Only members in good standing who have been members for three (3) or more months before the March election meeting can be considered for office.

The duration of the membership will be based on the original application date and the date of the March meeting. Nominations can be made from the floor at the February meeting and nominations will thereafter be closed. The ballot must be published in the March meeting newsletter delivered to members prior to the December meeting. No write in candidates will be allowed.

Mail in or delivered absentee ballots will be counted at the March meeting. These ballots must be enclosed in a plain envelope which is enclosed in an outer envelope legibly signed by the member.

ARTICLE VII
INITIAL BOARD OF DIRECTORS

The initial board of directors will consist of Naomi Parker, Constance Ruppender, Marcel Martin and Jack Moore. The method by which subsequent directors are elected shall be set forth in the By-Laws.

ARTICLE VIII
INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 400 N. E. 22nd Street, Wilton Manors, Florida 33305, and the name of the initial Registered Agent of this corporation is Naomi Parker.

ARTICLE IX
AMENDMENT PROCEDURE FOR BY-LAWS

The By-Laws may be amended at any regular meeting of this association when a quorum is present by a two-thirds vote of the members present. Such amendments must be submitted in writing to the President and membership by a member in good standing at the previous meeting. With the agreement of the originator, the executive committee may refine the amendment for presentation to membership by the president.

ARTICLE X
AMENDMENT TO ARTICLES OF INCORPORATION


The articles of incorporation may be amended by the same procedures set forth in Article IX concerning amendments to the By-Laws.




