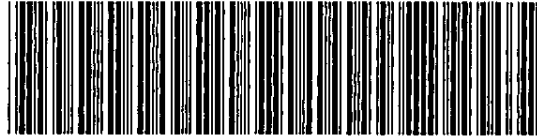

We, the undersigned, with other persons being desirous of forming a corporation for religious purpose, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following.

ARTICLE I. NAME

The name of the corporation is Mount Zion Christian Center Church, Inc., in Belle Glade, Florida. Located at 348 East Canal Street South, Belle Glade, Florida 33430.

ARTICLE II. PURPOSE

The general nature of the object and purpose of this corporation shall be: to operate exclusively for religious and educational purposes, including, for such purpose:

- a. To associate with other organizations or corporations of similar nature.

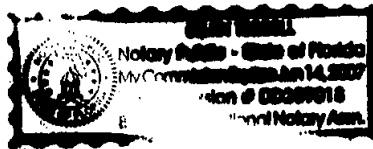
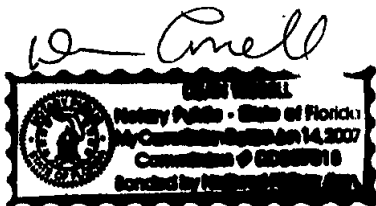
