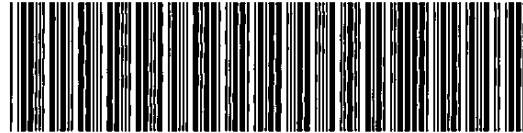

# ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

## Article I – NAME

The name of the corporation shall be:

The Well of Tallahassee, Inc.

## Article II – PRINCIPLE OFFICE

The principal place of business and mailing address of this corporation shall be:

## Article III – PURPOSE

The purpose for which the corporation is organized is:

The congregation is organized as a church exclusively for religious, charitable, and educational purposes under the rules and terms of the Florida Baptist Association, including but not limited to, for such purposes, the establishing and maintaining of religious worship, the buying, owning, and selling of real property, constructing and operating buildings and structures, and the winning of people to a saving trust in Jesus Christ as their personal Savior as well as the subsequent training of those individuals in following Jesus as Lord of their lives as they serve Him in ministry and outreach in our community and around the world.

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## Article IV – MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The initial directors were selected and appointed by the founders of this church body, Dean Inserra and Scott Simmons. They are to serve for one year. At the end of their term, they may be requested to serve another term or may be replaced at the discretion of the church body by a three fourths (3/4) vote of the church.
