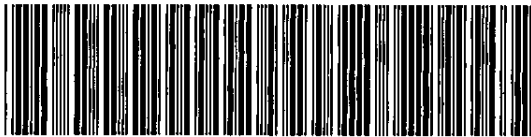

Said corporation is organized exclusively for charitable and religious purposes, including, for such purposes, the making of distributions to organizations and individuals that qualify under section 501(c)(3) of the Internal Revenue Code.
