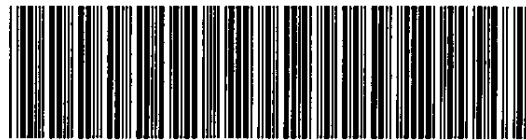

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

First: The name of the corporation shall be Friends of Pasco County Parks and Recreation Inc.

Second: The mailing address where the principle office of the Corporation is to be:

Third: Said Corporation is organized exclusively for charitable purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The intent being to (1) assist with maintenance of public facilities and (2) to lessen the burdens of the government.

Fund raising events and charitable donations will be accepted for the following: {listed for example but not in exclusion}

1. Dog agility equipment in the dog park.
2. Fitness trail equipment around paved jog trail.
3. Extra benches in Pet cemetery, along trail, and overlooking the lake.
4. White board, TV with video/disc player, computer in meeting room (old chapel).
5. Additional playground equipment to enhance the main unit.
6. Restoration of monuments and head stones in pet cemetery.(owned by county not currently in operation)

Forth: The names and addresses of the persons who are the initial trustees and directors of the corporation are as follows:

VP-T Michael Johnson

Fifth: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of

statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue code, of the corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, this corporation shall not except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Sixth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any of the assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

Seventh: The manner in which the directors are elected is stated in the bylaws.
