

**ARTICLES OF INCORPORATION OF
BERRY'S RIDGE HOMEOWNERS ASSOCIATION, INC.**

The undersigned, acting as incorporator of a corporation under the non-profit Corporation Act of the State of Florida, adopts the following articles of incorporation.

ARTICLE I - NAME

The name of the corporation is BERRY'S RIDGE HOMEOWNERS ASSOCIATION, INC.

ARTICLE II - EXISTENCE AND DURATION

Existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, State of Florida. The Association shall exist in perpetuity.

ARTICLE III - PURPOSES AND POWERS

The purposes for which the corporation is organized are:

- A. To operate BERRY'S RIDGE HOMEOWNERS ASSOCIATION and to undertake the performance of, and to carry out the acts and duties incident to the administration of BERRY'S RIDGE HOMEOWNERS ASSOCIATION in accordance with the terms, provisions, conditions, and authorizations contained in these Articles, the By-laws of BERRY'S RIDGE HOMEOWNERS ASSOCIATION, and the Declaration of Covenants, Conditions and Restrictions of BERRY'S RIDGE recorded among the public records of Volusia County, Florida;
- B. To carry out the duties and obligations given by the Declaration of Covenants, Conditions and Restrictions of BERRY'S RIDGE recorded among the public records of Volusia County, Florida; and
- C. To establish By-Laws and Rules and Regulations for the operation of BERRY'S RIDGE HOMEOWNERS ASSOCIATION and to provide for the formal administration of BERRY'S RIDGE HOMEOWNERS ASSOCIATION, and to enforce the Declaration of Covenants, Conditions and Restrictions of BERRY'S RIDGE recorded among the public records of Volusia County, Florida, and the By-laws of BERRY'S RIDGE HOMEOWNERS ASSOCIATION.
- D. The Association shall operate, maintain and manage the surface

water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District permit number 42-27-92646-1 issued July 29, 2004 for the development of the Berry's Ridge Subdivision, and the requirements contained therein, and applicable District rules, and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water or stormwater management system.

- E. The Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or stormwater management system.

ARTICLE IV - MEMBERSHIP

The qualifications for members and the manner of their admission shall be regulated by the Declaration of Covenants, Conditions and Restrictions of BERRY'S RIDGE recorded among the public records of Volusia County, Florida, and the By-laws of BERRY'S RIDGE HOMEOWNERS ASSOCIATION.

ARTICLE V - REGISTERED OFFICE

The initial registered office of the corporation shall be at 1053 Maitland Center Commons Blvd., Suite 200, Maitland, FL 32751.

ARTICLE VII - MINIMUM NUMBER OF DIRECTORS AND ELECTIONS

The initial board of directors shall consist of at least three members. The method of election of directors shall be as stated in the By Laws of the Corporation. The initial board of directors shall consist of:

ARTICLE VIII - OFFICERS

The affairs of BERRY'S RIDGE HOMEOWNERS ASSOCIATION shall be administered by a President, Secretary and Treasurer and Vice President, all of whom shall serve at the pleasure of the Board of Directors of BERRY'S RIDGE HOMEOWNERS ASSOCIATION. A person may hold more than one office with the exception of the President who may not also hold the office of Vice President. The following persons shall constitute the officers of the Association:

ARTICLE X - BY-LAWS

The By-laws of BERRY'S RIDGE HOMEOWNERS ASSOCIATION shall be adopted by the initial Board of Directors. The By-laws may be amended only in accordance with the provisions of such By-laws to be adopted by the initial Board of Directors, and only in accordance with Florida law. Provided, however, once the By-laws are adopted by the initial Board of Directors, no portion of the By-laws may be altered, amended, or rescinded in such a manner as it will prejudice the rights of West Lake Estates Properties, Ltd., a Florida limited partnership, or Mortgagees of real property located within BERRY'S RIDGE subdivision as described in the Declaration of Covenants, Conditions and Restrictions of BERRY'S RIDGE recorded among the public records of Volusia County, Florida.

ARTICLE XI - AMENDMENTS TO ARTICLES

These Articles may be amended in the manner provided for under Florida Law and the By-laws of BERRY'S RIDGE HOMEOWNERS ASSOCIATION.

ARTICLE XII DISSOLUTION

In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved by the St. Johns River Water Management District prior to such termination, dissolution or liquidation.


