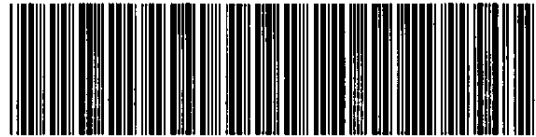

AMENDMENT
TO
**Articles of Incorporation
Robyn's Nest Ministries, Inc.**

The undersigned citizens of the United States, 18 years of age or older, desiring to form a not-for-profit corporation under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, hereby certify, acknowledge and adopt the following Articles of Incorporation:

**Article I
Name**

The name of this not-for-profit corporation shall be Robyn's Nest Ministries, Inc.

**Article II
Term**

The duration of the corporation, Robyn's Nest Ministries., Inc., shall be perpetual.

**Article III
Primary Office, Mailing Address & Branch Locations**

The location of the principal office of Robyn's Nest Ministries, Inc. and its mailing address is 10775 Danielle Dr., Largo, FL 33774.

Branch churches may be established at any time at any place according to the Robyn's Nest Ministries, Inc. Bylaws.

**Article IV
Purposes**

Robyn's Nest Ministries, Inc. is organized exclusively for religious, charitable and educational purposes, including the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, as may be amended.

Article V

Election of Corporate Directors

The directors of Robyn's Nest Ministries, Inc. shall be determined in accordance with methods and qualifications specified in the bylaws of the Corporation. In no event shall the number of directors be fewer than three.

The names and street addresses of the initial directors who shall be on the board of directors for Robyn's Nest Ministries, Inc. during the first year of the corporation's existence or until successors are chosen, are:

Article VI

Powers

The powers of Robyn's Nest Ministries, Inc. shall have all the corporate powers enumerated and set forth and in accordance with Chapter 617, Florida Statutes, and as amended, but is subject to any limitations set forth in the By-Laws of the Corporation and with the following limitations within the meaning of section 501(c)(3) of the Internal Revenue Code, as may be amended:

1. No part of the net earnings of Robyn's Nest Ministries, Inc. shall inure to the benefit of, or be distributed to its members, directors, officers or other private interests. Robyn's Nest Ministries, Inc. shall be authorized and empowered, however, to pay a reasonable flat salary for services rendered by its employees and to make payments and other distributions in furtherance of the purposes set forth in Article IV.
2. Only an insubstantial amount of the activities of the Corporation shall be in furtherance of a purpose not set forth in Article IV.
3. Only an insubstantial amount of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, within the meaning of section 501(c)(3) of the Internal Revenue Code, as may be amended, unless the Corporation elects the provisions of section 501(h) of the Internal Revenue Code, as may be amended.
4. In no event shall the Corporation have the power to participate in, or intervene in, including the publishing or distributing of statements, any political campaign on behalf of, or in opposition to, any candidate for public office, all within the meaning of section 501(c)(3) of the Internal Revenue Code, as may be amended.

5. In the event the Corporation chooses to litigate, using its own staff attorneys on behalf of its members or other clients, the Corporation shall comply with the guidelines provided within the Revenue Procedure 92-59, 1992-2 C.B. 411-12, as may be amended, superseded or modified. The bylaws of the Corporation shall adopt these provisions accordingly.

Article VII

Debt Obligations and Personal Liability

No member, officer or director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or directors be subject to the payment of the debts or obligations of this corporation. Robyn's Nest Ministries, Inc. shall indemnify all directors, officers and employees of the Corporation

Article VIII

Meetings

1. After incorporation, the appropriate members of the Corporation shall hold an organizational meeting in accordance with Chapter 617, Florida Statutes, as amended.
2. The board of directors of the Corporation may participate in a regular or special meeting by, or conduct the meeting through, the use of any means of communication which allows all directors participating to simultaneously hear one another or to simultaneously see the written communication of one another via the internet or through other electronic means that may exist at the time of the meetings. A director participating in such a meeting is deemed present at the meeting. In the alternative, the board of directors may take actions through signed email communications provided all board members agree.

Article IX

Article X Dissolution

Upon dissolution of Robyn's Nest Ministries, Inc., or the liquidation of its assets, whether voluntary or involuntary, or by operation of law, except, as and to the extent otherwise provided or required by law, and upon payment or adequate discharge of all liabilities and obligations, the net assets of the Robyn's Nest Ministries, Inc. shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, as may be amended, according to the Robyn's Nest Ministries By-Laws. In the event that the organization(s) identified in the By-Law is(are) no longer in existence or no longer meet the exempt purposes of section 501(c)(3) of the Internal Revenue Code, as may be amended, the net assets shall be distributed to the State of Florida or the Federal government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of Pinellas County or in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes. None of the net assets of the corporation shall be distributed to or for the benefit of any member, officer or director of the Corporation or to any other individual upon dissolution.


Article XI Registered Agent and Office

The Registered Agent of Robyn's Nest Ministries, Inc. is Robyn Coffman, a Florida resident, and the Registered Office of Robyn's Nest Ministries, Inc. is 10775 Danielle Drive, Largo, FL 33774.
