Articles of Incorporation of Ledgen's Field Foundation Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to provide the proper setting for groups and handicapped individuals, to grow, and to have the opportunity to participate in the sport of paintball and other outdoor activities that creates teamwork and ability to work with other people.
