

This \*ttachment is concerning the Amended Annual Report (filed on 7/14/08) and the Articles of Amendment (filed on 7/15/08) - both filed by Sabrenia Kelley-Lewis.

Specify the inaccuracy, incorrect statement, or defect:

### Amended Annual Report:

On July 14, 2008, Sabrenia Kelley-Lewis filed an Amended Annual Report containing false information. Ms. Kelley-Lewis went against the bylaws of the agency and took unilateral action to add 3 new Board Members to Therapy4Kids without a vote and/or approval from the majority of the members of the Board of Directors for Therapy4Kids and Families, Inc. The members that were unlawfully added include: Gloria Madaus, Torrance Solomon and Andrea Garwood. We are requesting that these 3 members who were unlawfully added, be removed from the Board of Directors.

In the July 14 Amended Annual Report, Ms. Kelley-Lewis also changed the principal place of business and mailing address without consulting the other board members and without cause. The mailing address and principal place of business should revert back to the original address of: 434 N. Meander Drive Altamonte Springs, FL. 32714.

In the July 14 Amended Annual Report, Ms. Kelley-Lewis also changed the registered agent to Sabrenia Kelley-Lewis, which was also done without the consent of the original registered agent and without consent/approval from the majority of the members of the Board of Directors. The registered agent should revert back to the original agent, Julie Henry. The registered agent's address should revert back to the original address of: 434 N. Meander Drive Altamonte Springs, FL. 32714. Ms. Kelley-Lewis, also changed the current principal place of business address and mailing address to her own personal address, without consent/approval from the majority of the Board of Directors. The current principal place of business address and mailing address should be changed back to: 434 N. Meander Drive Altamonte Springs, FL. 32714.

### Articles of Amendment:

On July 15, 2008, Ms. Kelley-Lewis unlawfully filed Articles of Amendment, in which she took unilateral action to amend the Articles of Incorporation to remove Julie Henry and Carey Colon as members of the Board of Directors. Ms. Kelley-Lewis did this without holding a meeting with the Board of Directors and without the approval and/or consent of Julie Henry or Carey Colon. We are requesting that Sabrenia Kelley-Lewis be removed from her position as Officer/Director and member of the Board of Directors. We are requesting that Julie Henry be added back to the Board of Directors as an Officer and President of the agency. We are requesting that Carey Colon be added back to the Board of Directors as an Officer and Vice President of the agency. We are requesting that Laura Lee be added to the Board of Directors as an officer and Secretary of the agency.
