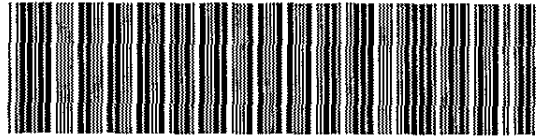

Articles of Incorporation of
Mobile Access Connections Corp.

The undersigned hereby makes, subscribes, acknowledges and file with the Secretary of State of Florida these Articles of Incorporation in compliance with Chapter 617 and/or Chapter 621, Florida Statutes, for the purpose of forming a Not For Profit Corporation (the "Corporation") in accordance with the laws of the State of Florida.

Article I. – Name

The name of the Corporation shall be Mobile Access Connections Corp.

Article II – Principal Office

The street address and mailing address of the corporation's principal office is 5542 Lake Howell Road, Winter Park, FL 32792. The corporation may change its principal office by filing with the Department of State of the State of Florida a statement complying with Section 607.0502 Florida Statutes.

Article III – Purpose

The corporation will provide community services to low income individuals and the elderly in their attempt to acquire private and public medical and other services, including, but not limited to Medicare and Medicaid. Such services will include identification of those individuals who need such services, provision of the proper forms and assistance completing forms for those individuals, identification of the appropriate method of filing or submitting such forms, and other assistance such individuals might need is acquiring medical and other services.

Article IV – Directors

Article V – Initial Officers/Directors

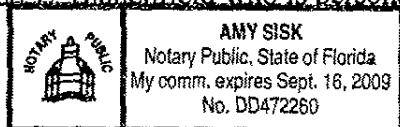
