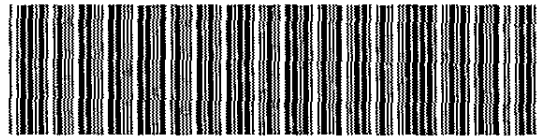

In compliance with Chapter 617, FS., (Not for Profit)

Article I - Name

The name of the corporation shall be:

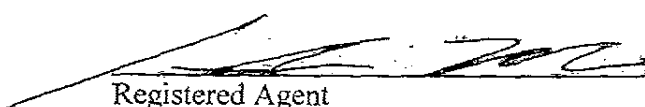

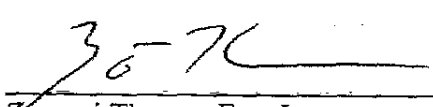
