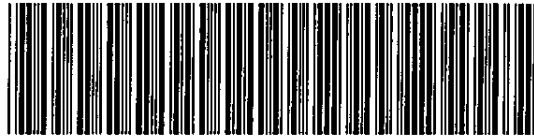

**ARTICLES OF INCORPORATION**  
In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

**ARTICLE I NAME**

The name of the corporation shall be:

**ARTICLE II PRINCIPAL OFFICE**

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

- (a) To establish a prototype system of education that effectively empowers youths to identify their purpose and fulfill their divine destiny in a Christian atmosphere that promotes spiritual growth, high standards of scholastic achievement and excellence in the arts and sciences, all housed in a technologically advanced state-of-the-art learning facility infused with a comprehensive and rigorous academic curriculum implemented by dedicated, well-paid professionals in a nurturing environment established on the fundamental Biblical principles of self-control and unconditional love. Once established, the prototype will be made available in a turn-key franchise format for purchase to individuals, corporations and municipalities in the U.S. and abroad. The ultimate goal is to provide an effective alternative to the public K-12 education system that focuses on the development of the whole person-spirit, soul and body and establishing the AGAPE schools worldwide,
- (b) To organize and establish a community outreach marching band composed of musicians, dancers, and twirlers for teenaged youths, ages 13-19 of all races, socio-economic, religious and ethnic backgrounds designed to build self-esteem, confidence and character in youths allowing them to aesthetically express themselves while rendering service to the community by performing, locally,

nationally, and internationally, demonstrating the positive and powerful influence of unity through Biblical principles of love, hope and grace expressed in the performing arts,

- (c) To create a Christian-based Community Organization providing post-school day learning and recreation activities such as, academic tutoring, private and group instruction in the arts; computer and internet access areas, sports, and other enrichment activities during the school year. The ultimate goal is to establish full-service community resource/family recreation and fitness centers that will also serve as an after-school center, a summer camp facility during the summer months and a refuge for teenagers in need of outpatient emotional, and spiritual counseling and guidance services. The ultimate goal is to maximize out of school time (MOST) of adolescent youth.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

**ARTICLE IV MANNER OF ELECTION**
