# Articles of Incorporation

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida due herby certify:

### Article I

# Article IIII

The specific purpose for which this corporation is organized is:

The Corporation is dedicated to the promotion, encouragement and development of young artists who are ready to take the next step into the world of performing Arts. Our programs will benefit all performers, regardless of their level of expertise. The corporation will organize and operate seminars, master classes, discussion panels and lectures on voice, stage deportment, the business of a career in music, focus on acting and audition techniques, resumes, languages, appearance, and representation. The participants will work with leading singers, coaches, conductors, stage directors, general managers, and artist managers who will mentor their progress. Participants will have opportunities to perform during the various programs which will offer audiences productions of the highest quality.

## Article IV

Said corporation is organized exclusively for charitable, religious, educational and scientific purposes and no part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in

furtherance of the purposes set forth in Article III. No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

### Article V

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the Principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
