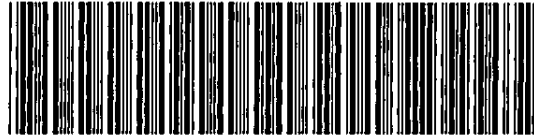

**Article I      Name**

The name of the corporation shall be:

**Article III      Purpose**

The purpose for which the corporation is organized is:

Exclusively for charitable, professional, educational and civic purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purposes of the Division are: (a) to provide a forum for the young and new lawyers to learn and address the duties, responsibilities and problems of the members of the Bar; (b) to provide a program of activities and projects designed to be of interest and assistance to the young and new members of the SCYLD; (c) to carry out projects for the betterment of the Bar, Bench, Community and Scholastics; and (d) to coordinate the association of young and new members of the SCYLD with their counterparts in other county, state, and national Bar Associations and (e) to include all young lawyers in all areas of practice.

**Article IV      Manner of Election**
